One of them is through health and safety efforts (Law of the Republic of Indonesia No. 36 of 2009 concerning Health)

Personal Protective Equipment provided by the agency requires knowledge and behavior that supports achieving occupational health goals. If the acceptance of new behavior or adoption of attitudes through this kind of process, which is based on knowledge, understanding, and positive behavior, the attitude will be maintained (long lasting) (Rahimudin Mufti Lubis et al. 2023.)

One Data Indonesia Employment Priority Data 2023 recorded that in 2023 the number of work accidents in Indonesia was 347,855 cases for wage earners and 19,921 cases for non-wage earners. West Java is the province with the highest number of accident cases in Indonesia, namely 62,808 cases for wage earners and 1,824 for non-wage earners. (One Data Indonesia Employment 2023)

The results of a preliminary study on May 13, 2024 through an interview with one of the sources, namely the operator in charge of the Sumedang Regional General Hospital, the number of work accident cases in the generator set room was 3 cases of work accidents consisting of 1 operator whose arm was splashed with sulfuric acid (battery water) when filling the battery water, 1 operator whose eye was splashed with diesel fuel when filling the fuel, and 1 mechanic was trapped in the arm when changing the oil filter on the unit.

Workplace accidents can be caused by two factors, namely human actions that do not meet safety standards and unsafe environmental conditions. But 80-85% of the consequences of accidents are humans, due to human negligence itself. This negligence can be caused by two factors, first because of employee indifference to the dangers of work accidents that threaten, they only pursue wages without caring about their own safety, second because of lack of awareness caused by lack of intelligence or knowledge about work safety (Transiska et al. 2015).

2. METHOD

This research method uses a qualitative method where researchers are directly involved with their research subjects to gain in-depth insights into various aspects of human, social, or cultural life. This method provides space for complexity and context that cannot always be measured in numbers, allowing researchers to explore broader dimensions of social reality. Fact in the field show that the workers No use tool protector self because of feel No comfortable moment Work for example worker feel hot moment use a helmet when Work moment Work so that worker the take off the helmet when work (Sum'mamur in Risnawati Cape 2022)
